Dear Ms [REDACTED], thank you for again contacting the European  
Medicines Agency.

In our initial response, we communicated that *'from the very large body of evidence assessed by international regulators, there is no evidence suggesting that COVID-19 vaccination may be linked to adverse reactions manifesting as long-lasting symptoms'* and that *'if emerging evidence supports the existence of long-lasting symptoms, appropriate regulatory action will be taken'*.

We have nothing we can add to our initial response.

Therefore, again, although we sympathise with people who have experienced these reaction, we are not able to accommodate your request.

Your question(s):Dear sir/madam, I'm contacting you regarding your response with reference ASK-275574 - ICD, in which we've made the request to urge the World Health Organization to include post-vaccination syndrome on the ICD list. You've responded that vaccines are safe. Whether they are or not, however, is a different discussion. Our question was not regarding vaccine safety, it is about patient care. With numerous national and international PVS patient organizations around the globe, the recognition of PVS on the ICD list is well overdue. Post-covid patients do not have a biological marker either, fibromyalgia neither, etcetera. Yet, if thousands of patients experience and share common symptoms and have organized themselves in great numbers, one can no longer deny its existence.
